Application Deadline: The following material must be received by Widener University Commonwealth Law School before **March 15, 2017**:

- 1. Completed application form.
- 2. **Personal Statement.** A personal statement is required discussing why you would like to participate in this program. You may also include a statement discussing other circumstances in your background that demonstrates how your admission into law school in the future would help to correct under representation of a particular minority or disadvantaged group in the legal profession. *500 words or less.*
- 3. **Official undergraduate transcript.** The minimum cumulative undergraduate grade point average requirement is 2.5. An official undergraduate transcript must be submitted with the application. Please submit an official transcript from every undergraduate school you have attended. All candidates must be in good academic standing.
- 4. **Two letters of recommendation.** At least one letter must be from a college professor or dean. Letters of recommendation should discuss your academic potential, writing ability, and professional promise.
